Hello I'm Reashelle Banister. I am a single mother of a one year old daughter. I work as a direct support professional at one of Heaven's Hands Community Services Day Service Hab programs. I've been with HHCS for 3 years.

I am incredibly passionate about what I do and I enjoy working with people with developmental disabilities each day. I grew up in this field as both of my parents work with individuals with developmental disabilities and have continued to do so for the past 30 years. Growing up, I saw the passion that my parents had in supporting the lives of people with developmental disabilities. They would come home each night and tell inspiring stories related to helping individuals; it was clearly apparent to me that they both loved what they did for a living. Community Hab work, I am able to provide support to my individuals while in their home, while at work and while out in the community. I work as an advocate for the individuals in helping them to best express their needs wants and concerns in an effort to craft individualized supports, achievable goals all based on outcomes that are meaningful.

I am also a full time student pursuing a bachelor's degree in Cognitive Studies. My motivation to continue my education is because I want to continue my career in the field of Developmental Disabilities, even one day reaching a management level position. I know it's not an easy job, but I know it will be a job that I will love.

Overall, I can say with pride, that I love helping to support the dreams and lives of people with developmental disabilities. There is no greater achievement than being able to help an individual find their productive or social niche in the community or reach an individualized goal. It brings real purpose to my life; I feel like I'm truly making a difference in people's lives.
