PRESIDENT'S MESSAGE...

A BITTERSWEET MESSAGE

This has been a very hard message to write. I became President of GROW eight years ago. While I am eager to pass the torch on to a new and qualified team, I sometimes feel like a deserter. People with developmental disabilities and their parents are being buffeted with so many changes and so much still needs to be done. However, as previous GROW presidents have done, I intend to remain active on the Board. Only now I won't have to set the agenda, etc...etc..etc....!!

I recently attended an OPWDD Transformation meeting. Many parents and some advocates spoke. Whether it was the closure of a developmental center without adequate planning for its residents, or a lack of OPWDD transparency, or a lack of appropriate residential opportunities across the board, or managed care, or constant changes in self direction, no one was happy. Since an e-mail sent to me stated that there would not be time for me to speak, I did not prepare a speech. However there was time, and after hearing one sad story after another, I addressed the audience rather than the panel.

In my remarks I was inspired by a book I am currently reading. It is called Neuro Tribes: The Legacy of Autism and the Future of Neuro Diversity by Steve Silberman. The author credits parents for establishing much needed services for people who are on the autism spectrum. He mentions names of people that I knew and in some cases worked with! It dawned on me that without parents all these OPWDD officials and all

the people running agencies that support people with developmental disabilities would not have jobs!

It must be remembered that it was the parents of persons with Down syndrome that created what was then called OMR as a distinct agency from the Department of Health. Later the parents of individuals with autism added developmental disabilities to the OMR, making it OMRDD. Now it is called OPWDD. Now, with managed care and commercial insurance companies handling everything, I fear that we are going back to "the bad old days" when there was no special agency for people with developmental disabilities.

I URGE ALL FAMILY MEMBERS TO REASSERT THE POWER THAT YOU POSSESS!!

Contact your legislators; demand transparency of and input in agencies and OPWDD.

Come to GROW meetings. **YOUR VOICE MUST BE HEARD!!!**

Directions to Cedarwood Hall - WIHD WESTCHESTER INSTITUTE FOR HUMAN DEVELOPMENT

FROM THE SOUTH: Sprain Parkway North to Eastview - 100C - Exit. Go Left.

****** At Hospital entrance (Second light) go right. Go 4/10 of a mile (passing the county jail) and go left following the sign for All Other Facilities. When you get to the T intersection bear right until the Stop sign. Turn left around oval.

FROM THE NORTH: Sprain Parkway South to Eastview 100C exit. Go right. Follow directions from ****** above.

FOR PARKING: Go around circle, pass through parking ticket dispenser and park in lot opposite Cedarwood Hall. Ask for parking voucher at reception desk.

BUS DIRECTIONS: Routes 1, 15, and 14 will leave you off at Elmwood Hall, a short distance from Cedarwood Hall. Route 40 will leave you off at Westchester Hospital, a longer walk.

NEW PROCEDURE FOR RESIDENTIAL REQUESTS

The process for residential placement in an OPWDD certified home is now called the Certified Residential Opportunities (CRO) protocol. It is essentially a vacancy management program that will keep a database of individuals' needs and residential vacancies available. Each DDRO has a CRO team; Region 3 (Capital District and Hudson Valley) is headed by Vicki Tobar. An individual's service coordinator or other referral source completes a residential request form, along with a full packet of information, and sends it to the CRO team. The packet includes a statement signed by families that their service coordinator discussed other residential options with them. The CRO team reviews the information and assigns a placement priority designation. Agencies then receive the information from the CRO team in order to match it with their current openings.

Since there will be a limited number of openings in existing certified houses, GROW understands that the CRO team will be looking to place the highest priority individuals. In addition agencies are under financial pressure to fill these vacancies as soon as possible. GROW is concerned that this situation sometimes results in individuals being placed in residences that are not appropriate for them or for the residents who currently reside there.

OPWDD is in the process of calling families of individuals presently on the Residential Request List, formerly known as the NY State Cares List, to assess their needs more thoroughly. They will be asked if they still need certified residential services, what services they currently have and what other services may be helpful.

OPWDD will be presenting the findings of this survey to the State legislature by February 2016 and will use the information for its future residential planning.
